Campus Hazing Transparency Report

St. Joseph's College of Nursing July 2026

The Stop Campus Hazing Act (SCHA) is a piece of legislation that became law in December 2024 that requires, among other things, institutions develop and distribute a Campus Hazing Transparency Report (CHTR, or "Report") and report hazing statistics in the Annual Security Report as required by the Clery Act.

St. Joseph’s College of Nursing Hazing Policy & Procedure

St. Joseph’s College of Nursing’s policy regarding hazing and the procedures used to prevent it can be found in your Student Handbook. This policy was adopted and published on June 6, 2025.

REPORTING PROCESS

St. Joseph’s College of Nursing encourages the reporting of incidents of hazing and takes each report seriously. It will investigate all reports diligently and thoroughly, in accordance with the applicable institutional policies (i.e. Code of Student Conduct, Sexual Violence and Prevention, etc.). Any person may report an incident of hazing in person, by mail, by telephone or electronic mail, using the contact information listed for Sara Peña at sara.pena@sjhcon.edu.

CAMPUS HAZING TRANSPARENCY REPORT

Per the SCHA, St. Joseph’s College of Nursing will compile and publish relevant and pertinent information¹ regarding each incident of hazing for which a recognized student organization was found responsible. Beginning July 1, 2025; this information will be collected and subsequently published (and updated) twice a year².
